Overview

The **A TEC LTA** line is the most technologically advanced offering of Teller Cash Recyclers (TCRs) in the market today. The LTA 380 is the shorter cousin to the 450 and designed for ADA stations or CSR desk implementations while remaining a high cash capacity TCR. With more than 2000 units deployed across the US, customers appreciate the unique features that help streamline business operations. The concept began with a study of teller TCR processes to see what could be improved over previous generations of all manufacturers' units. Focusing on "living with a TCR", the Atec engineers worked to solve issues of cash management, cash exposure, vault buys and capacity. The research and development paid off with a product line which makes branch operations simpler with TCRs that do more, do it better, and take less overall management.



Unique by Design

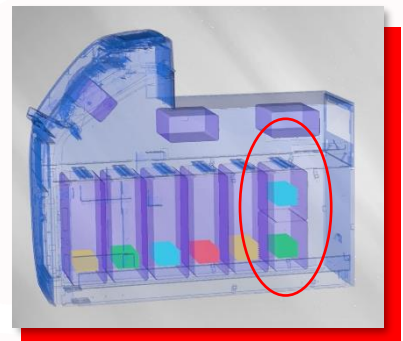
Capacity has always been a concern for the first and second generation TCRs. Low capacity adds to cash management and teller time, defeating some of the benefit. The LTA line has by far the largest capacity in both sit-down and teller height configurations

utilizing a flexible cassette-based recycler. The LTA line can hold a huge amount of cash and is suitable for commercial teller stations.

Operations / Transit Cassette. The operations cassette has revolutionized the management of the cash in the TCR. This versatile cassette enables the LTA to perform **full, unattended self-audits**. This amazing feature will save countless cash management hours over the life of the unit. The operations/transit cassette allows tellers to move excess cash within the TCR and to securely transport cash within the branch. In operations mode, the cassette acts as an overflow, a large deposit storage, or the audit-cash bin. In a transit capacity, this cassette can be loaded or unloaded securely in a back office, then transported to the LTA to load or unload the unit without exposing cash to the public.

Cassette configuration is electronically coded. This allows teller supervisors to change denominations to suit the circumstances. For instance, banks located in tourism areas near the seashore, will typically have higher demands for smaller bills used for cashier tills as well as higher commercial cash deposits. A teller supervisor could re-code the cassettes to the appropriate denominations for the 3 months of summer, then change back in the fall. No billable technician visit is required.

Split Cassettes for maximum flexibility. The LTA line can be configured with any combination of full or split cassettes for a mixture of 6-12 denominations. The cassettes are electronically coded and can also handle foreign currency.



Dedicated Counterfeit Suspect Output Pocket. Unique to the LTA, this dedicated Counterfeit-Suspect pocket separates the suspicious bills, so they are treated differently

from other rejected bills. This ensures that counterfeit bill protocol is followed so counterfeit bills are never taken into your GL or redispersed to the public.

Life is Better with an LTA. The unique features that make up the LTA are what makes life better when owning, operating and managing TCRs. This carefully engineered product line was designed to fix the problems inherent in older generation machines. You will quickly realize the benefits the first time you perform an unattended self-audit and settle without touching a dollar.

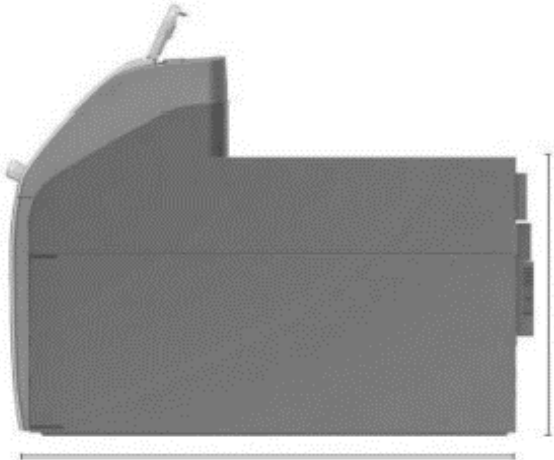
