How does Shields Business Solutions protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We restrict access to your personal and account information to those employees who "need to know" that information to provide products or services to you.

How does Shields Business Solutions collect my personal information?

We collect your personal information, for example, when you

- Request information online as a non-customer
- Establish a business relationship with us

We may also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

DEFINITIONS

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

We do not currently have any affiliates with whom we would share your information.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

We do not currently have any nonaffiliates with whom we would share your information.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
